ARTICLE SUBMISSION GUIDELINES:

1. Articles are submitted on the sheets of A4 page size (210x297 mm) with 2 sm edges of all sides; paragraph indent – 1,25 sm, single spacing. Text size: font size: 12 «Times New Roman».

2. For each article index УДК should be specified (on the left side, in capital letters, in bold print); JEL Classification (Journal of Economic Literature) – in the line underneath.

3. Name, surname – on the right side, in bold print, font size 14.

4. The surname is followed by the institution name – of normal text size.

5. The title of the article – in the middle of the page, in capital letters, in bold print, font size 14.

6. Abstract in Ukrainian – a word «Анотація» in italics, in bold print. Abstract text – in italics. Abstract content should be concise and clear (1800-2000 signs), the purpose, tasks and outcomes should be specified. Recommendations on Abstract writing.

7. Key words – words «Ключові слова» – in italics, in bold print. A list of keywords – in italics.

8. The title of the article – in the middle of the page, in capital letters, font size 14.

9. Name, surname in English – on the right side, in bold print, font size.

10. Key words in English – a word «Keywords» – in italics, in bold print. A list of keywords – in italics.

11. The title of the article – in the middle of the page, in capital letters, font size 14.

12. Abstract in English – a word «Abstract» – in italics, in bold print. Abstract text – in italics.

13. Text references should be in the brackets, for example [1], [1, 6], [1, p. 5].

14. All figures must be captioned, tables must be entitled.

15. References must be listed in alphabetic order.
